The amount of the charges is determined in the Tariff on Fees, collected by the State Telecommunications Commission (STC) (hereafter called the "Tariff on Fees") passed by Decree No 31 from 19 February 1999 by the Council of Ministers.

The initial licence fees for issuing of individual licences depend on the type and scope of the licensed activity and are determined in Art.2, p.1 of the Tariff on Fees for the following activities, which in 2000 were subject to individual licensing:

- television broadcasting;
- television activity;
- radio broadcasting in the 66-74 MHz and 87.5-108 MHz frequency bands;
- radio broadcasting in the FM and VHF;
- radio activity;
- cable telecommunications networks for radio and television signals;
- wire radio:
- networks and services for personal calling;
- analogue mobile TRUNK networks;
- digital mobile TRUNK networks;
- VSAT networks:
- cellular mobile networks NMT è GSM;
- cellular mobile networks with local coverage;
- terrestrial fixed satellite stations;
- fixed radio relay lines, analogue;

- fixed radio relay lines, digital;
- MVDS 40 GHz television networks;
- TFTS telephone network;
- WBDTS broadband data transmission systems;
- public networks for data transmission;
- DECT as WLL systems;
- · Systems of payphones for public use;
- autonomous mobile radio telephony networks PMR and PAMR;
- satellite terrestrial terminal equipment;

The initial licence fees for registration under class licences depend on the type and scope of the licensed activity and are determined in art.3 of the Tariff on Fees for the following activities, which in the year 2000 were subject to registration under a class licence:

- mobile satellite terminal devices;
- satellite terminal devices for news reporting purposes;
- radio relay lines for news reporting purposes;
- ship and aircraft radio stations;
- networks and terminal devices, using ISM frequency bands;
- amateur radio stations:
- Citizen Band (CB) radio stations 27 ÌÍz;
- autonomous networks for data transmission;
- installation and operation of payphones for public use;
- value added services:
