The issuance, amendment, suspension and withdrawal of individual licenses continued during the year 2002. The process of amendment of granted licenses upon request by the operators was quite active.

The process of creation and improvement of auxiliary documents necessary for issuance of individual licenses and registration under general licenses kept on as well: applications, declarations, technical attachments for the respective types of activity, requirements concerning technical projects etc.

3. ACTIVITIES OF CRC ON THE JOINT WORK WITH THE COUNCIL FOR ELECTRONIC MEDIA (CEM)

- A number of work meetings were conducted between CEM and CRC for coordination of the activities related to the bound licensing;
- Preparation was made on launching competitions for TV broadcasting in 8 settlements and for radio broadcasting in 7 settlements;
- Drafts of tender documentation and licenses were worked out;
- A draft of Strategy for Development of Radio and TV Activities Through Terrestrial Broadcasting was prepared and moved in November 2002 for adoption by the National Assembly.
