On the grounds of article 90, para 5, in connection with article 93, para 2 and 3 of the Law on Electronic Communications (promulgated in State Gazette issue 41/2007), with regard to its Decision № 1893 of 04 September 2008 and an protocol decision № 1/23.10.2008

THE COMMUNICATIONS REGULATION COMMISSION

DECIDED:

- **1.** Announces an auction with secret bidding for granting a right of use of individually assigned scarce resource radio frequency spectrum for provision of public electronic communications through mobile terrestrial network under GSM standard with national coverage for 10 years term. The granting of such a right will ensure the provision of individually assigned scarce resource radio frequency spectrum $2 \times 15 \text{ MHz}$ of the 1800 MHz range in radio frequency bands 1741,3000 1756,3000 MHz and 1836,3000 1851,3000 MHz.
- **2.** Natural persons sole proprietors and legal entities can participate in the auction, for which the following requirements shall be available:
- 2.1. The person/entity shall have experience in the provision of public electronic communications (the provision of an activity by a person/entity, who exerts control over the management of the applicant, is accepted also as experience in the provision of electronic communications activity).
- 2.2. The person or the company, who exerts control over the management of the applicant should have over BGN 1 000 000 (one million leva) annual turnover for 2007.
- 2.3. The person or related with him persons as per the meaning of § 1 of the Additional provisions of the Commercial Law should not possess a right of use of individually assigned scarce resource radio frequency spectrum for provision of public electronic communications through mobile terrestrial network under GSM standard on the territory of the Republic of Bulgaria.
- 2.4. The person, in case it is not a local legal entity or a legal entity registered in EU memberstate, is obliged, if it wins the auction, to register a local legal entity, which is 100% its property, to

which the Communications Regulation Commission will transfer the right and which solely will have the right to provide electronic communications based on the granted right.
