

## REGISTRY OF CERTIFICATION SERVICE PROVIDERS OF UNIVERSAL ELECTRONIC SIGNATURE

### (TRUSTED LIST)

The Communications Regulation Commission (CRC) has registered five Certification Service Providers (CSP) of Universal electronic signature. The Decisions to accredit these CSPs are based on Art.35 of the Law on Electronic Document and Electronic Signature (LEDES). Based on Art.34, para.1 of LEDES, CRC publishes the certificates of the registered CSPs.

The certificates are also available for download on the websites of the registered CSPs.
