VI. BUDGET

CRC budget implementation, distribution of revenue receipts and costs incurred in 2012

With the Law on State Budget, the Ministry of Finance has set BGN 60 million as revenue target of CRC for 2012. During the year, receipts to the Commission's budget totalled BGN 69.117 million, which represents a 15% overfulfilment of the revenue part. The revenue overfulfilment is due to collected receivables for past periods and the paid one-off fee for amendment and supplement of authorization for the use of individually assigned scarce resource – radio frequency spectrum for the provision of public electronic communications via a land mobile network - UMTS, issued to the BULGARIAN TELECOMMUNICATIONS COMPANY AD.

The execution of the revenue part of the CRC budget was as follows:
