VI. BUDGET

CRC budget implementation, distribution of revenue receipts and expenditures incurred in 2009.

With the Law on State Budget, the Ministry of Finance has set BGN 42.9 million as a CRC revenue target for 2009. During the same year, receipts to the Commission's budget totaled BGN 47.241 million, which represents a 10% overfulfilment of the revenue part.
