IV. BUDGET

CRC budget implementation for 2017

The Communications Regulation Commission is a primary administrator of budget.

By the Law on State Budget of the Republic of Bulgaria for 2017, the Ministry of Finance has determined for the CRC:

• Revenue in amount of BGN 60 000 thousand;

• Expenses in amount of BGN 9 318 thousand.

The Commission administers revenue pursuant to Art.51, para.1 of the LEC and Art.62 of the PSA.

In 2017 the revenue earned from fees, penalty notices and interest amounted to BGN 54 509 thousand which was 91 % fulfilment of the annual plan. Regardless of the public consultations on the prospects of using the available resource in the 1.5 GHz, 2 GHz, 2.6 GHz and 3.6 GHz radio frequency bands, it was not used, which resulted in non-fulfilment of the annual task.

On the other hand, the Commission continued to apply the following good practices to increase the revenue collection while expanding and supplementing them in order to facilitate the undertakings' activity.

- Information about the terms and the methods of fees payment was published every quarter on the Commission's website.

- E-mails about the terms and the methods the terms and the methods of fees payment were generated automatically.

- Personalized e-mails about the specific obligations of the undertakings in case of delay were sent.

E-invoices were issued on request.

- Personalized e-mail about the fees to be paid was sent when issuing and/or amending or supplementing an authorization for use of individually assigned scarce resource.

Additional actions for increasing the revenue collection undertaken by CRC:

- Issuance of acts for establishment of public state receivables when public debts to CRC had not been paid

- Sending of enforcement of unexecuted acts for establishment of public state receivables and penal decrees to the National Revenue Agency by which in 2017 additional revenue amounted to BGN 30 thousand was collected.

In 2017 the budgetary funds spending was carried in strict compliance with financial discipline and the principles of legality, appropriateness, effectiveness and efficiency. Projects, assigned to the CRC by legislative acts were implemented of priority.

The implementation of CRC investment policy enabled the updating of the applied radio monitoring service, which increased the efficiency of the radio frequency spectrum monitoring. It

was purchased a system for measuring the coverage, QoS and speed of data transfer of the mobile terrestrial networks.

Information service

In 2017 CRC continued its activity on construction of its internal and external information systems in order to improve the quality of the administrative employees' work, to make easier the citizens and business access to information and electronic administrative services provided. The activities concerning the Commission participation in e-Government projects in the Republic of Bulgaria are the following:

• Support and operation of an information system "Licensing and registers", providing 39 on-line administrative services to the citizens and business. The Information system was elaborated and financed from Operational Programme "Administrative capacity" and certified under the Ordinance on the general requirements for interoperability and information security. The information system "Licensing and registers" assists the management of information processes on CRC electronic registers maintenance and the provision of public on-line access, in compliance with the requirements of the LEC, the Law on electronic documents and electronic signature (LEDES) and the PSA. The system is connected with document processing system in order "Eventis" to get incoming numbers of he received documents through "Licensing and registers, resolutions etc.

• Operation of Document Portal to the document processing system "Eventis" enabling the citizens and business to send digitally signed documents and receive electronic statements by CRC.

• Creating of organizational, communication and information environment for efficient and transparent operation of CRC administrative staff which shall meet the Government strategy for development of the electronic management in the Republic of Bulgaria for the period 2014-2020.

The implementation of these activities will contribute to reducing the costs, improving the services provided and transparency in CRC activities. In 2017 the work on renewal and development of CRC website continued, as well as the internal system of contents management. The new website will allow the users to have easier access and use of different terminal devices.
